Dave Carey is a sought after professional speaker, trainer and an accomplished consultant. ## THE PRESIDENT'S COLUMN



### **GROWING PAINS**

As you all know, PMI is growing at a rapid pace, and has been doing so for a number of years. As such, there are various growing pains at various stages of growth. Some of those growing pains were the subject of motions that were brought up at the last Leadership Meeting in Orlando. Below is an excerpt of two of the more challenging motions upon which the Chapter Presidents voted.

Background: The 1996 version of the PMBOK was available for sale in a bound version from the PMI bookstore. However, it was also available free of charge in a format that allowed it to be downloaded from the PMI web site. Currently the 2000 version of the PMBOK is not available

in a free download version.

Motion: We, the PMBOK Guide Copyright Issue Working Group, move that the ACP Board of Directors communicate to the PMI Board of Directors that the sense of the Assembly is to recommend that the PMI Board develop policies to provide clear direction to Headquarters staff in their implementation of the existing PMBOK Guide copyright. The direction should include:

- Copyright infringement actions should only be taken in the case of willful and blatant copying, reproduction, and sale of all or a substantial portion (multiple consecutive chapters) of the PMBOK Guide.
- Corporations, trainers and consultants should be encouraged to freely adopt all or any portion of the PMBOK Guide into their standards, procedures, methodologies and materials provided suitable credit is given PMI
- The electronic version of the PMBOK Guide should be offered free and in unlimited down load quantities via the PMI web site provided the Adobe File is encrypted to prevent further copying unless appropriate credit is given to PMI. Standards, contributors and reviewers should only be required to sign an ethics statement acknowledging that it is unprofessional to knowingly provide previously copyrighted material to PMI while representing that material as their own.

Motion made to amend the motion regarding the point of encryption unless appropriate credit is given to PMI. Modified motion carried.

Background: PMI Headquarters drafted a Charter that all components would be required to sign. The Charter defined the roles, responsibilities and relationship of PMI Headquarters and the Components. This draft was released for comment and feedback. Many Chapters provided feedback, including the Orange County Chapter. When the final version was released, many components did not think that their feedback was heard. In a meeting at the Leadership Conference, Steve Townsend, Manager of Component Affairs, and Hugh Woodward, Chairman of the Board of Directors, addressed the concerns of the component leaders and indicated that they were withdrawing the Charter and would do further work before re-releasing it.

Motion: I move that the ACP Board of Directors communicate to the PMI Board of Directors that the sense of the Assembly is that a Task Force of concerned and involved members should be convened for the purposes of determining by consultation and negotiation a Component Charter document that will address the needs of the members as well as the longer term viability and protection of the organization.

The establishment of such a group is in compliance with normal project management (stakeholder involvement) and quality management procedures and is in direct compliance with Executive Limitation Ends Policy 2.10.1.

The Assembly acknowledges that a formal document defining the relationship between PMI Inc. and the PMI Components is required. However, it is the sense of the Assembly that substantial issues remain with the proposed Component Chartering document and further work is required to make the document acceptable to both PMI Inc. and the many Components.

#### Motion carried.

If either of these are issues that you have strong feelings about, I encourage you to get involved to whatever degree you can. PMI is your association. There are some critical issues that we as an organization are facing right now. Your input makes a difference. I can tell you from personal experience, that your actions can impact the way the organization runs. If you want to get involved, I can point you in the right direction. If you would like to see the entire list of motions from the Business Meeting, I will get you an electronic copy.

- The PMBOK® Guide—2000 Edition was approved as an American National Standard (ANS) (ANSI/PMI 99-001-2000) on 27 March 2001, superseding the PMBOK® Guide – 1996 Edition as PMI's American National Standard in Project Management. The PMBOK® Guide – 1996 Edition should no longer be referred to as an ANS. (sfahrenkrog@pmi.org)
- As a reminder, a Call for 2002 PMI Board Committee, Project Team and Member Advisory Group (MAG) Appointments was published in the February 2001 issue of PMI Today<sup>®</sup>. There are numerous opportunities for participation, and interested volunteers should visit PMI's Web site at www.pmi.org/governing to review current charters for these groups. If you would like to serve as a volunteer, a Statement of Interest and a professional biography must be forwarded by 1 June 2001 to the PMI Executive Director (execdir@pmi.org). All Statements will be forwarded to the PMI Chair for review and consideration during the appointment process. (admin@pmi.org).
- PMI's 2001 Annual Seminars & Symposium has extended the deadline to submit accepted Symposium papers to Friday, 13 April 2001. If you have questions, please contact Bobby Hensley, Symposium Coordinator at proceedings@pmi.org. The 2001 Annual Seminars & Symposium will be held in Nashville, Tennessee USA, 1-10 November 2001.
- Due to the overwhelming number of requests received each month for permission to use excerpts from the PMBOK<sup>®</sup> Guide—2000 Edition, PMI has developed a Frequently Asked Question (FAQ) Web page on this topic. This new and informative FAQ may be found by clicking on the words "Intellectual Property" on PMI's home page within the PMBOK<sup>®</sup> Guide—2000 Edition download area. The FAQ answers routine questions about the permission process and contains a direct link to the Information Check List Form, the beginning point for persons seeking permission to use excerpts of the PMBOK<sup>®</sup> Guide—2000 Edition. Automating this portion of the permission process maximizes efficiency and speeds up the turn-around time, providing access to this process 24 hours a day, seven days a week. (pmbokperm@pmi.org)
- PMI has introduced a new section to the organization's Web site called "About Project Management." This section is based on a printed brochure that PMI developed in 2000 called "Project Management: A Proven Process for Success." PMI's 2000 Marketing Member Advisory Group (MAG), comprised of Alan Kristynik, PMP; Kelly Slone, PMP; and Jan Smid, supported this project. The new section can be reached by going to www.pmi.org and clicking on the "About Project Management" button at the left-hand side of your screen. Or, you can type in www.pmi.org/projectmanagement to go directly to the site. The "Proven Process" brochure is targeted to individuals who have little or no knowledge about project management, and it is available in limited quantities on an individual request basis by contacting PMI's Customer Service Department. It can also be downloaded in PDF format at the end of the "About Project Management" section of the PMI Web site. (agoretsky@pmi.org)
- The scheduled 2001 update of the Project Management Professional (PMP\*) Certification Examination has recently been developed. PMP candidates should note that the PMBOK Guide\*— 1996 Edition was used as a reference for the 2001 examination. The PMBOK Guide\*—2000 Edition will be used as a reference for the 2002 examination, which is currently in development. (progmgr@pmi.org)

• The PMP Role Delineation study was validated in 2000 and is available for purchase at the PMI Bookstore (www.pmibookstore.org). The Role Delineation study outlines the PMP Certification Examination's content areas, including Professional Responsibility, and is a good resource for candidates preparing for the examination. In addition to being used to establish the test specifications for the examination, the study describes the tasks and competencies PMPs perform, as well as the project management knowledge and skills PMPs use to complete each task. Each of the study's tasks is linked to a performance domain (e.g., planning the project). Each task has three components to it: what the task is, why the task is performed, and how the task is completed. (progmgr@pmi.org)

As postal mail is not always reliable in some locations of the world, electronic balloting will enable our global membership the opportunity to cast their vote in a timely manner.

In 2001, eligible voting members are offered a choice of receiving election materials via the Internet or United States Postal Service (USPS). To submit your preference for either Internet or U.S. postal receipt of election materials by 30 April 2001, and to update your preferred e-mail address, visit www.pmi.org/members. If a preference is not registered, election material automatically will be forwarded electronically and members who do not cast an electronic vote by 10 August 2001 will be sent the election material via USPS.

# THE FIVE STEPS OF LEADERSHIP

The session that stands out most clearly in my mind was a presentation by Richard Owen, *Sales as a Project*. It resonated with me because I don't see myself as a salesman. I have always viewed myself as a technical, systematic manager who uses tried and true techniques to accomplish reasonable objectives. However, Richard is a born salesman, and yet he uses the PMBOK model (Initiating, Planning, Executing, Controlling, and Closing) in structuring his sales activities. He uses the same approach that I use for my technical development projects, and he applies it to a field that I normally associate with unstructured, unscrupulous egotists (I realize that this says more about me than about the sales profession). Richard Owens taught us how the PMBOK model can pertain to any project and that you can add your own flair to the basic model.

The PMI Leadership meeting is an excellent opportunity for anyone interested in how PMI works and interested in what can be done to develop and expand local chapters. I loved it and encourage every volunteer and especially board officers to attend, at least once.

My focus for the three days was: How to Recruit and Develop Volunteers. Listed in the next column are some conference highlights that I will pursue for our chapter (not necessarily in priority order):

### VOLUNTEER RELATED

- Sell the benefits of being a volunteer–we all can do this. So develop a short elevator speech that you can use to quickly present PMI-OC as the opportunity arises.
- Use a discussion list to stay in touch with your group. (I have already implemented this for all PMI\_OC\_VOLUNTEERS via YahooGroups.)
- Create a brochure for Ambassadors to present to first time visitors at our dinner meetings. (Volunteer Stacy Steck took this idea and ran with it, providing our chapter board of directors with a draft at the last board meeting.)
- Document what you want a volunteer to handle, make it specific and manageable, define tasks in terms of deliverables and quality and not method.
- Ask (one-on-one) a person to volunteer; be persistent
- Ida Harding led an excellent session called "How to Develop Component Members into Future Officers." Her presentation slides are in the conference binder and are an invaluable asset for anyone interested in developing quality leaders.

### MISCELLANEOUS

- If you want a reply to your email, say so in the subject line
- Fact: majority of PMI members have belonged less than three years
- Fact: PMI attrition rate in 2000 was 24%
- QUOTE: "There is only one thing worse than training your volunteers and having them leave, and that's not training them and having them stay."
- Networking tip for the next dinner meeting: practice your elevator speech on two people you don't know

I spent three enlightening days in beautiful Orlando with four terrific officers of our chapter, and many, many wonderful PMI members from all over the world. It is an experience that I heartily recommend to all my fellow PMI members. Attending can change your life, at least for a while.
