

A New Year's Resolution: Take a Chance

Year after year, many of us make New Year's resolu-

tions: lose weight, change jobs, retire, or take a long vacation.

I have a New Year's resolution for both the chapter leadership and members; take a chance and do something different. We go to a typical dinner meeting. We attend a few advanced topic seminars. We hold an annual development conference. We support SoTeC Of course, the chapter needs to present these kinds of events. But, is there a better way? Or, are there other options that can be beneficial to the members?

Keeping the chapter's mission of providing value to the members in mind, the current board has begun to make changes.

We initiated a joint venture to provide Agile training last spring. We created a joint session with Dale Carnegie for soft skill training for project managers. We began holding free networking events in addition to the standard dinner meetings.

We held a Christmas party/ networking session in December instead of the regular dinner meeting. We created a presence in the social networking arena, namely our Facebook page, and Twitter and LinkedIn accounts. A new board is about to be installed, and for the first time ever, there will not be a sitting or designated president at the outset. The new board members will negotiate with each other to determine what roles are to be played by what members.

My challenge will be to continue and expand this trend. We need to seek out and try new things. But, there are only seven of us on the board. There are nearly 1,700 members. Each member probably has at least one idea to increase value.

My challenge is to explore other ways to provide value. Greater use of online delivery mechanisms to offer PDUs could be an option. We need to find a more generous way to recognize and reward volunteers. We must find better ways to engage the members on a regular basis.

We have sufficient resources to try out new and different approaches. My resolution is to be more open to new thoughts, new ideas, and new ways to provide value. My hope is that the members will join me in this new perspective.

Tots Program, Orange County Social Services, Orange County Firefighters, and others.


All donations are trucked to a central distribution center from which they are taken to smaller centers and given to underprivileged children in Orange County.



December ATS Review

Project Portfolio Management Easily Applied

Joe Brannon of

the Management Institute of Southern California, gave us an excellent reason to attend both the monthly dinner meetings and advanced topic seminars. As the speaker at both events, he proved that his presentation became more valuable by attending both.

Joe's presentation about portfolio management, which he defines as "a dynamic decision process where project lists are continually updated and revised; new projects are evaluated, selected, and prioritized against existing projects; existing projects may be accelerated, cancelled, or de-prioritized; and resources are allocated and re-allocated in alignment with organizational strategic objectives."

Joe identified the purposes of portfolio management:

- Tracking active and inactive projects.
- Reducing uncertainty by determining how projects add value to organizational goals.
- Obtaining clearer understanding of active project status.

Joe pointed out that many organizations don't know what





projects are underway, let alone how they relate to each other or the organization's goals, and that a list of active projects may be insightful to senior management. In addition, with effective portfolio management, project priorities and resources can be adjusted to align with organizational priorities.

After the first hour, we broke into small teams and practiced prioritizing and ranking projects. As part of the exercise we used sample worksheets, which we took home and used.

During our projects we had to define the strategic objectives associated with the case study being used. Our strategic objectives had to be "future looking, affirmative, concise, realistic, on point, and measurable," with measurable being the most

important characteristic. If you can't measure the objective, how do you determine if you have succeeded?

- withdraw or modify their request voluntarily
- If there is no stated goal, it doesn't matter where you go.



Next, we used several factors such as cost, risk, return, priority, and organizational alignment to rank our strategic objectives.

In some cases, the interesting outcome was that objectives that appeared as low ranking became high ranking because of organizational alignment or as a required predecessor to other projects.

Recommended policies:

 When asked to add a new project or change the scope of an existing project, never say no; always give options. This allows the person to
